## **A fundraiser with a legal twist**

*Local lawyers star in a staged reading of 12 Angry Men as a fundraiser for Saint John Theatre Company*

On April 21<sup>st</sup>, twelve local lawyers and one judge will get a taste of real courtroom drama when they perform on stage at Imperial Theatre in a staged reading of Reginald Rose's *Twelve Angry Men* as a fundraising event for Saint John Theatre Company.

"It's going to be a lot of fun," says Stephen Tobias, Artistic Director for Saint John Theatre Company. "The lawyers we have involved are really working hard to create a great evening of entertainment."

*Twelve Angry Men* is a suspense-filled drama that follows the debate of a 12-member jury deliberating the fate of a man being tried for first-degree murder. The verdict must be unanimous, and a guilty verdict carries a mandatory death penalty.

Earlier this year, Tobias contacted Nathalie Godbout from Lawson Creamer law firm and asked if she thought a group of lawyers could be persuaded to perform in the show as a fundraising event for Saint John Theatre Company's new theatre education initiatives.

"When Stephen approached me to help coordinate the event, I didn't hesitate for a moment," says Godbout. "The lawyer-actors signed up willingly and enthusiastically. This is just our humble attempt to give something back to our community."

Rehearsals have been underway for the past few weeks, working around the busy schedules of the lawyers involved. The cast members have been excited about the chance to be involved in a unique event that supports a great cause and gives them a chance to try something new.

"I got involved because SJTC makes our community a more enjoyable place to live," says Craig Wilson from Cox & Palmer. "And you don't win Tonys practicing law."

For Robert Jette from Clark Drummie, the play was an early inspiration. "It's wonderful to be involved in this presentation. As lawyers, we can't serve on juries. This is a privilege."

The performance will be staged for one night only at Imperial Theatre on Wednesday, April 21 at 7PM. Tickets are \$45.
